## Housing Division – Inspectors



**The Department for Social Development's Housing Division is seeking to compile a new list of Inspectors who may be appointed to take charge of public inquiries into housing issues and proposals for the extinguishment of public rights of way.**

Inspectors are appointed by Housing Division to conduct public inquiries into Vesting Order Applications and Extinguishment of Public Right of Way proposals which are submitted to the Department by the Northern Ireland Housing

Executive. The most recent public inquiry was of that into the Application for a Vesting Order for the Village Urban Renewal Area Belfast.

A public inquiry is arranged by the Department following the receipt of a significant number of objections to a proposed vesting or extinguishment of public right of way. At a public inquiry an Inspector will consider evidence from a range of interested parties. This evidence may be in the form of written

submissions or oral evidence. An Inspector may also seek out other information that he/she considers appropriate or necessary.

The Inspector's role is to act as an independent arbiter of the facts presented at a public inquiry and make an informed and reasoned recommendation on the proposed scheme.

After the inquiry has closed the Inspector will prepare a report which constitutes the formal record of the Inquiry. This report should include a list of the persons who appeared at the Inquiry and of the documents presented; a description

of the site, proposal or scheme and any key evidence; the Inspector's findings of the facts; and reasoned conclusions and recommendations.

The length of a public inquiry varies with some lasting up to two days. High profile inquiries may attract media attention.

As the frequency of public inquiries is irregular the Department maintains a list of Inspectors and makes appointments on the basis of availability. Remuneration is the daily rate payable for Chairs and Members of public bodies, travel and subsistence allowances will be paid in accordance with the current rates, as determined by the Department, details of which are available on request.

## Vacancies

Included in this edition of 'All Aboard' is a list of the public appointment vacancies that are expected to arise during the first half of 2011. Any vacancies that arise after we go to print will be added to our website.

If you are interested in any of the vacancies listed, please contact the designated official who can provide you with more information about the appointment and when it is due to be filled. ●



This is a very important role that can have a significant and lasting impact on communities, the economy and the demography of an area. Inspectors will be required to analyse complex information, manage the public inquiry process and prepare reports that demonstrate logical and reasoned arguments.
